

## PREVAILING WAGE RESOLUTION

**WHEREAS**, the State of Illinois has enacted “An Act regulating the wages of laborers, mechanics and other workers employed in any public works by the state, county, city or any public body or any political subdivision by anyone under contract for public works,” approved June 26, 1941, as amended, being Section 39s-1-12, Chapter 48, Illinois Revised Statutes, 1973, and

**WHEREAS**, the aforesaid Act requires that the Northern Suburban Special Education District investigate and ascertain the prevailing rate of wages as defined in said Act for laborers, mechanics and other workers in the locality of said Northern Suburban Special Education District employed in performing construction of public works, for said Northern Suburban Special Education District.

**NOW THEREFORE, BE IT ORDAINED BY THE LEADERSHIP COUNCIL OF THE NORTHERN SUBURBAN SPECIAL EDUCATION DISTRICT:**

**SECTION 1:** To the extent and as required by “An Act regulating wages of laborers, mechanics and other workers employed in any public works by state, county, city or any public body or any political subdivision or by anyone under contract for public works,” approved June 26, 1941, as amended, the general prevailing rate of wages in this locality for laborers, mechanics and other workers engaged in construction of public works coming under the jurisdiction of the Northern Suburban Special Education District is hereby ascertained to be the same as the prevailing rate of wages for construction work in Lake County area as determined by the Department of Labor of the State of Illinois as of **MAY 2018**, a copy of that determination being attached hereto and incorporated herein by reference. The definition of any terms appearing in this Resolution which are also used in aforesaid Act shall be the same as in said Act.

**SECTION 2:** Nothing herein contained shall be construed to apply said general prevailing rate of wages as herein ascertained to any work or employment except public works construction of the Northern Suburban Special Education District to the extent required by the aforesaid Act.


**SECTION 3:** Northern Suburban Special Education District shall publicly post or keep available for inspection by any interested party in the main office this determination of such prevailing rate of wage.

**SECTION 4:** Northern Suburban Special Education District shall mail a copy of this determination to any employer, and to any association of employers and to any person or association of employees who have filed their names and addresses, requesting copies of any determination stating the particular rates and the particular class of workers whose wages will be affected by such rates.

**SECTION 5:** Pursuant to the requirements of The Illinois Revised Statutes, 1973, Chapter 48, Chapter 39s-1-12, Northern Suburban Special Education District hereby determines to publish the notice herein required in the Pioneer Press, a newspaper of general circulation with the territory of said public body.
